



You're right about one thing, Governor...

Well, your latest "flip-flop" isn't fooling anyone. Your record is what it is, and the facts speak for themselves. In case your memory has become fuzzy, here's a little refresher on the truth:

FACT: WHEN NEARLY 80 PERCENT OF WISCONSIN VOTERS APPROVED A STATE CONSTITUTIONAL AMENDMENT AFFIRMING OUR RIGHT TO KEEP AND BEAR ARMS, YOU OPPOSED IT.

Now, your political party would like voters to believe you supported the amendment to protect hunters' rights. But conveniently, they make no mention of the Right to Keep and Bear Arms in Wisconsin.

FACT: TWICE – IN 2003 AND 2006 – YOU VETOED "RIGHT-TO-CARRY" BILLS THAT THE WISCONSIN LEGISLATURE PASSED OVERWHELMINGLY.

Even your fans can't deny this one; they just present excuses and continue spouting their anti-gun agenda, which includes making gun ownership records public.

FACT: WHEN YOU WERE ATTORNEY GENERAL, YOU SUPPORTED LEGISLATION THAT WOULD HAVE BANNED VIRTUALLY ALL AMMUNITION AND FIREARMS - EXCEPT SINGLE SHOTS – IN WISCONSIN.

How do your followers respond? They say it was a mistake. Someone wrote the bill poorly. Excuses, excuses... What *really* happened was that you realized it would have been political suicide to pursue the bill, and you had it withdrawn.

Governor Doyle, here are a few more of your anti-gun ideas that your supporters wouldn't even try to defend:

FACT: YOU TRIED TO SHUT DOWN GUN SHOWS THROUGHOUT THE STATE.

You supported legislation requiring that people who buy handguns at gun shows wait 48 hours before taking possession of their firearms. That was an attempt to stop all handgun sales at gun shows in Wisconsin, and you knew it.

FACT: YOU SUPPORTED HOLDING LAW-ABIDING FIREARMS MANUFACTURERS AND GUN CLUBS RESPONSIBLE FOR THE ACTS OF CRIMINALS.

Your veto of AB 56 was nothing more than a thinly veiled attempt to bankrupt lawful firearms manufacturers and gun clubs.

FACT: YOU OPPOSED STATEWIDE UNIFORM GUN LAWS.

That means honest, licensed hunters would instantly become criminals when they cross the line into Madison. Only someone intent on making criminals out of law-abiding citizens could oppose statewide uniform gun laws, but you did!
