FEDERAL

- Secured the removal of the \$200 federal excise tax on suppressors and short-barreled firearms.
- Worked to secure confirmation of President Trump's pro-Second Amendment Cabinet Secretaries.
- Blocked veterans from being arbitrarily stripped of their Second Amendment rights.
- Continued to block attempts to criminalize private firearm transfers.
- Blocked legislation that would ban semi-automatic firearms and "large-capacity magazines."
- Continued to work to block legislation that would create broad, new categories of Americans that are banned from possessing firearms.
- Safeguarded pro-gun protections in federal spending bills.
- Blocked legislation that would create indefinite delays for lawful gun buyers.
- Working to grow the pro-gun majority in the U.S. Senate.
- Working to expand the pro-gun majority in the U.S. House.

STATE & LOCAL

- 20 states now prohibit the use of firearm/ammunition-specific merchant category codes, with three additional states (Ohio, South Dakota, Arkansas) signing legislation into law this year.
- Louisiana, Oklahoma, Tennessee and West Virginia all passed NRA-backed legislation strengthening liability protections for the firearm industry.
- Pennsylvania passed legislation removing the prohibition on Sunday hunting.
- Governor Abbott signed a package of bills protecting and expanding Second Amendment rights in the Lone Star state, including universal carry recognition.
- Governor Reynolds signed legislation to lower the carry age to 18 in Iowa, recognizing the right of self-defense for young adults.
- Legislation was signed eliminating so-called "gun-free zones" in several states, including Louisiana, Oklahoma, and South Dakota.
- Governor Youngkin vetoed more than two dozen anti-gun bills, protecting the rights of law-abiding Virginians.
- Governor Lombardo vetoed all anti-gun legislation that reached his desk, continuing his commitment to protect the Second Amendment rights of Nevadans.
- Efforts to ban commonly owned semi-automatic firearms were defeated in New Mexico and Hawaii.

GRASSROOTS




- Participated in over 205 in-person events throughout the country to educate and motivate NRA members and Second Amendment Supporters.
- Hosted 190 NRA 2A Days to recruit thousands of volunteers and NRA Members.
- Hosted over 100 virtual meetings and trainings to educate our grassroots volunteers.
- Contacted over 750,000 voters in the Virginia and New Jersey elections in support of NRA-PVF endorsed candidates.

LITIGATION



- Invalidated New Mexico's 7-day waiting period for firearm purchases in the Tenth Circuit Court of Appeals.
- Invalidated California's background check requirement for every ammunition purchase in the Ninth Circuit Court of Appeals.
- Invalidated the Biden ATF's "engaged in the business" rule in federal district court.
- Invalidated the Biden ATF's "pistol brace" rule.
- Invalidated California's ban on the promotion of firearm-related products that may be attractive to minors.
- Filed three lawsuits challenging the National Firearms Act's restrictions on suppressors, short-barreled long guns, and NFA-defined "any other weapons."
- Filed lawsuit challenging California's ban on Glock-style handguns.
- Filed lawsuit challenging New Jersey's "one-gun-a-month" restriction.
- Filed lawsuit challenging New Jersey's ban on suppressors.
- Filed lawsuit challenging Massachusetts' ban on "assault-style firearms."
- Filed lawsuit challenging Massachusetts's restrictions on adults under 21.
- Filed lawsuit challenging Florida's waiting period law for firearm purchases.
- Filed lawsuit challenging Colorado's excise tax on firearm and ammunition sales.
- Filed lawsuit challenging BLM's shooting ban on the Sonoran Desert National Monument.
- Petitioned the U.S. Supreme Court to hear challenges to California's magazine ban; Florida's purchase ban for adults under 21; and the NFA's restrictions on short-barreled rifles.
- Filed 20 amicus briefs in lawsuits across the country, including 9 in the U.S. Supreme Court.
